#### SHGSPC RALLY TRIAL



#### A CAUTIONARY "TAIL" - OUR TPLO STORY - KAREN REILLY



Some of you know that Eamon tore his left cranial cruciate ligament (CCL) while chasing a rabbit in early October. He did it late afternoon on a Saturday. He was non-weight bearing, but had no noticeable swelling and no cuts, so I had a good idea what it was. I gave him rimadyl and gabapentin and crossed my fingers that I was wrong. The next morning, he was still non-weight bearing so I took him to our local Emergency/Specialty practice – one that I have a nearly 20-year history with. The ER vet confirmed a torn CCL and recommended a surgeon to do a TPLO on Wednesday. Based on the reputation of the hospital (the best!) and a long personal history, I agreed. I did not know the surgeon (the surgeon I knew the best retired during COVID), but did not ask any questions – "it's one of the

best hospitals around and she has to be good", is what I thought. WRONG!

The surgery went "fine" but a few days later we were back at the ER. He had a fever and the surgical site was hot although the actual incision looked great – clean and dry. He had a cone on when I wasn't with him and had not touched it. They sent me home with simplecef. The next day I was back with a very sick dog. Not eating or drinking, vocalizing in pain and a high fever. One look at him and the ER doc said he needed to be admitted and on IV antibiotics. I agreed. He had cellulitis at the surgical site. His white count was severely low and he was dangerously neutropenic. I spent my entire career in the healthcare industry and I know that the goal for hospital/surgically acquired infections is always zero, but occasionally they sneak through. Boy does it suck when you fall into that "occasionally".

He recovered from the infection but never really recovered from the surgery. He continued to be non-weight bearing and painful. He also developed neurologic symptoms – knuckling of the toes and tremors. I was frustrated because he was shifted from surgeon to surgeon and none of them seemed overly concerned. I never heard from the surgeon who actually did the surgery. Long story short, I made an appointment with the owner of the practice and he diagnosed Eamon with severe sciatic nerve pain and ordered a CT and MRI. Nothing showed up. He diagnosed Eamon with "wind-up" pain. A phenomenon that occurs during periods of extended chronic pain (after surgery or severe injury) – to oversimplify, the nerves go "haywire" and fire continuously. He prescribed amantadine in addition to his gabapentin and rimadyl. One month later he had made significant improvement and was cleared for off-leash activity. He had been on leash for FIVE months – ALL THE TIME. It was welcome news and we were all thrilled.

A couple of days later he chased a squirrel and tore the CCL ON THE OTHER SIDE!! And now to the whole point of telling the story. This time, I insisted on an experienced surgeon who had performed this surgery too many times to count – and here's why. I found out that the surgeon who performed the first surgery was young and not yet board-certified and had limited experience with TPLO. She was also leaving on her honeymoon the next day and perhaps – in a rush and maybe didn't pay enough attention to sterile surgical technique?? The other surgeons I'd seen leading up to seeing the owner were all in that same class of "residents" who were waiting to take their second set of boards.

During the second surgery I opted to have the first implant removed. The implant itself, was too small for his size and the head of one of the screws was sheared off (likely occurred at the time of surgery when the screw was tightened in place) and it was infected with an anaerobic bacteria. AAAGGGHHH.

Well, it's nearly six weeks after the second surgery and I'm happy to report that Eamon is doing extremely well and we have 5 more weeks of leash time (yup that's going to be 8 months of leash time!!). But the moral of the story is this — no matter how well you know a practice, no matter how many times you've been there, no matter what the reputation is, no matter how routine the procedure is — **ASK ALL THE QUESTIONS, ALWAYS!** Unless you're (God forbid) faced with an immediately life-threatening situation and time is critical, **ASK THE QUESTIONS!!** Are you board certified? How many years of experience do you have? How many times have you done this procedure?

I wish I had asked this time, but always will in the future!!


